
ADMINISTRATIVE ORDER

Pursuant to Local Rule 6.03(A)(5), the bi-annual certification review of Alternative Dispute Resolution (ADR) neutrals was concluded on May 31, 2009. The rule provides that each even numbered year, the Clerk shall examine the list of certified neutrals to determine which neutrals did not receive appointments during the previous two years. The Clerk shall notify those neutrals that the Court's records does not show any appointments for those years, and shall solicit their interest in continuing to be carried on the Court's list of certified neutrals. If the neutral desires to remain on the list, the neutral shall submit by March 1 information demonstrating ADR experience and/or training during the previous two years. If such information is not provided the neutral shall be removed from the list.


The Clerk has examined the list of neutrals, and notified those not in compliance with said rule. The Clerk has prepared a list of neutrals that failed to respond by May 31, 2009 and submitted the list to the Court for review.

IT IS HEREBY ORDERED that the name of each attorney appearing on the list appended to this order shall be removed by the Clerk of Court from the list of ADR neutrals certified in the United States District Court for the Eastern District of Missouri.
