ALL PETITIONERS ARE SCHEDULED TO TAKE THE OATH OF CITIZENSHIP BY THE UNITED STATES CITIZENSHIP AND IMMIGRATION SERVICES. FOR INFORMATION GO TO WWW.USCIS.GOV

PETITIONERS ARE TO REPORT ON THE DATE, AT THE TIME AND AT THE COURTHOUSE LOCATION SPECIFIED IN USCIS CORRESPONDENCE.

ON THE DATE OF YOUR CEREMONY, AT THE COURTHOUSE AND PRIOR TO THE COMMENCEMENT OF THE NATURALIZATION CEREMONY, A BRIEF INTERVIEW WILL BE CONDUCTED BY USCIS PERSONNEL. IF A PETITIONER DOES NOT COMPLETE THIS INTERVIEW HE/SHE WILL BE RESCHEDULED FOR ANOTHER CEREMONY BY THE USCIS OFFICE.

PETITIONERS SHOULD ARRIVE AT 9:30 A.M. FOR DISTRICT COURT CEREMONIES THAT BEGIN AT 11:00 A.M. AND ARE SCHEDULED AT THE THOMAS F. EAGLETON UNITED STATES COURTHOUSE.

PETITIONERS SHOULD ARRIVE AT 11:30 A.M. FOR DISTRICT COURT CEREMONIES THAT BEGIN AT 1:00 P.M. AND ARE SCHEDULED AT THE OLD COURTHOUSE AT THE JEFFERSON NATIONAL EXPANSION MEMORIAL (4TH AND MARKET).
