All participants are reminded of the prohibitions regarding photographing, recording and broadcasting of court proceedings (Local Rule 13.02 (FRCP 83)). Participants who violate Local Rule 13.02 (FRCP 83) may face sanctions including, restricted entry to future hearings, denial of entry to future hearings, or any other sanctions deemed necessary by the judicial officer.

Local Rule 13.02 (FRCP 83) Use of Photographic, Recording and Communication Equipment states:

(A) All means of photographing, recording, broadcasting and televising are prohibited in any courtroom, and in areas adjacent to any courtroom, except when authorized by the judge. Unless specifically authorized by the judge presiding over any court proceeding, spectators may not use laptop computers, cell phones, or any other electronic devices in any courtroom. Nothing in this rule is intended to prohibit the use of electronic audio and visual devices for the presentation of evidence, for making the official record of a proceeding, for insuring Court security, or when authorized by the judge.
