## ALL COURTHOUSES OF THE EASTERN DISTRICT OF MISSOURI ARE OPEN TO THE PUBLIC. HOWEVER, ENTRY TO THE FACILITIES WILL BE DENIED IF YOU:

• Have travelled to any foreign country within the last 14 days;

• Reside or have had close contact with someone who has travelled to any foreign country within the last 14 days;

• Have been asked to self-quarantine by any doctor, hospital or health agency;

• Have been diagnosed with, or have had contact with, anyone who has been diagnosed with COVID-19 within the last two weeks;

- Have unexplained fever, cough or shortness of breath;
- Have taken a COVID-19 test for which a result is still pending;
- Register a temperature above 100 degrees on the automated thermometer;
- Refuse to wear a mask or face covering over the nose and mouth in all common areas.

**NOTE:** Judges or agency heads have authority to enforce entry standards, social distancing requirements, and gathering sizes within their court or agency. Persons should only enter the facilities for specific business purposes and should leave after their business is conducted.

## **POST-VISIT REPORTING REQUIREMENT**

• All courthouse visitors are required to notify the court or agency they visited, should the visitor exhibit any COVID-19 symptoms within 14 days of their visit to the courthouse.
